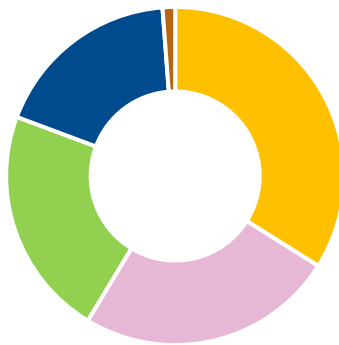
FUND DESCRIPTION

The Fund invests primarily in Irish properties, with some exposure to both UK and European properties. The fund is diversified across retail, commercial and industrial units.

The value of the Fund may fluctuate considerably over relatively short periods. In some years the return provided may be negative, perhaps significantly so. Property is a relatively illiquid asset which may exacerbate market fluctuations (both up and down) and may also lead to delays in implementing redemptions (or withdrawals) from the Fund.

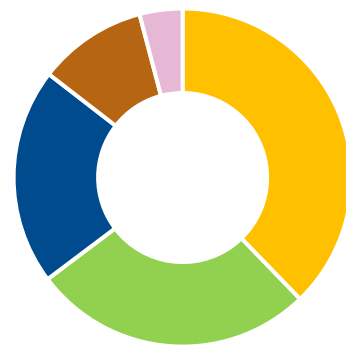
MANAGER SPLIT - AS AT 31-12-2025 *

- UK - 4.1%

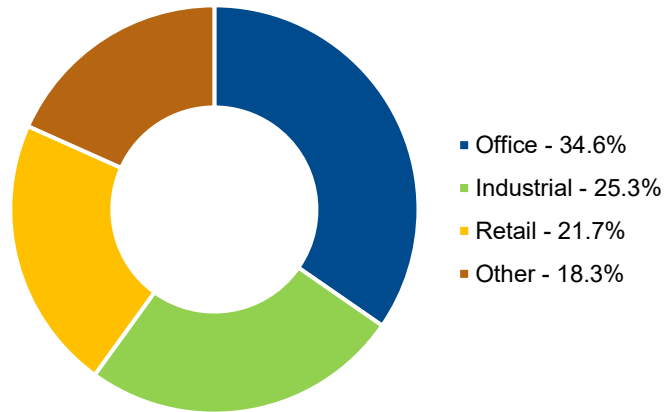
